DAUPHIN COUNTY

Dauphin County DRC Graduates 35 Reentrants

On November 7, 2019, the staff and reentrants of Dauphin County RSC gathered with members of parole and probation, as well as loved ones, to celebrate the achievements of reentrants who completed programming.

This event marked the sixth graduation of the RSC and spoke to the level of commitment to change each reentrant took in their respective journeys through the program. Graduates were presented



with a certificate and awarded a candle signifying finding their light in the dark, as well as a king-sized Hershey treat to go along with the Hershey treats earned throughout their time in the program.

Finally, each graduate was presented with a grounding stone printed with a random word. The stone can be carried by the graduates as a reminder. When the graduate is faced with triggers, hard decisions, or negative influences, looking at the word will assist with centering thoughts and bringing a sense of clarity to the situation. The imprinted word should be kept at the forefront of the graduate's thought process and serve as a reminder of the tools learned in the program.

Participant wins Top Tier Prize

Contingency Management is a system of rewarding or sanctioning in order to change behaviors over time. The purpose of contingency management is encouraging prosocial behaviors. Because reinforcements work better than sanctions so there is a ratio of at least four positive rewards to one sanction. Erie Outpatient's Contingency Management is structured around the participant's attendance, negative urinalysis, best participant in class, and completion of homework assignments. Since beginning the Contingency Management program over a year ago, there have been many rewards ranging from Tier 1 to 3.

There has been only one Tier 4 winner, Mr. Tore Sorles, who won the prize for completing treatment with perfect attendance in both groups and individual sessions, as well as negative urinalysis throughout his entire treatment. For his accomplishments, he was presented with a reward valued up to \$100. Mr. Sorles' Counselor, Ricky Lowe, reported that Mr. Sorles was also an exemplary participant.



He was not only present for all of his group and individual sessions, but he was always at least 20 minutes early. This is pro-social behavior we love to encourage in the participants we serve.

LYCOMING COUNTY

Lycoming County RSC Case Manager's Desire to Help Others

Nicole English, Case Manager at the Lycoming County RSC, was recently featured on one of Central Pennsylvania's most prominent online news websites, **On the Pulse**.

According to the website, On the Pulse is, "A team of dedicated journalists intent on bringing quality, in-depth reporting to the central Pennsylvania region" (www.onthepulsenews.com). Ms. English, was approached to be interviewed for the news site to bring awareness to the RSC mission.

Ms. English chose this field because she has a passion for helping people. By being featured on the news site, she has helped to further educate the community on the RSC and its mission. She said the program exists to help those with a criminal background, not to punish them. She added that participants show positive changes while in the program and the staff enjoy assisting participants to make those changes.



The interview also allowed Ms. English to show members of the community that those involved in reentry are not just criminals, but people who have made poor choices in the past and are prepared to make changes. Additionally, Ms. English, along with all Lycoming County RSC staff, have helped in showing the community that its participants are capable of being productive members of the community.

YORK COUNTY

Clothing and Shoe Drive

One participant, Mr. Moore, lost everything in a house fire and had to find a new residence and start all over. He was so grateful for the help with clothing and food and spoke about how it is already hard enough to start your life over without a fire.

Mr. Quinones was another participant who recently moved out on his own. He was excited and overwhelmed with this life change. He utilized the clothing and food drive to help him get back on his feet. He said, "The RSC has helped me become a better person in life. It has also helped me to get more organized and on the right path. I'm getting help with learning how to budget, gain employment,

and learn what is available to me for transportation. It takes time for me to trust people and I feel I can trust the staff at the York RSC to have my best interest."

York County RSC sees when participants trust and believe in this process, they open up and see the benefits of the program.

Both had near perfect phase progressions throughout the course of treatment and successfully completed all phases of the voluntary aftercare program. As their sense of commitment grew during the process, Ms. Cruz and Mr. Ubiles-Negron faced challenges, but they practiced good self-regulation and problem-solving skills and leaned on the positive support networks they built.

Although this graduation was small, it was intimate and powerful. For the 11 reentrants who were celebrated, it was another new beginning!
